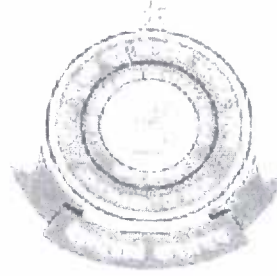

**PUBLIC NOTICE NO. 05/2011 DATED 27.05.2011**

In exercise of the powers conferred upon the Commissioner of Customs under Section 8(a) of the Customs Act, 1962, I, Vijay Kalsi, Commissioner of Central Excise and Customs, Thiruvananthapuram, hereby approve the area, as detailed in the schedule below, to be the proper places for the purpose of landing of imported goods and the loading of export goods or any class of such goods, including mail, courier and passenger baggage, subject to the strict observance of all relevant provisions of the Customs Act, 1962 and other instructions issued by the government of India from time to time.
